RESOLUTION 23-20
RESOLUTION OF THE HUMBOLDT COUNTY ASSOCIATION OF GOVERNMENTS
APPROVING A 2% BICYCLE AND PEDESTRIAN LOCAL TRANSPORTATION
FUND ALLOCATION

WHEREAS, the Humboldt County Association of Governments (HCAOG), in its official capacity as the Regional Transportation Planning Agency has adopted HCAOG Transportation Development Act (TDA) Rules and Regulations delineating procedures for the submission of claims under Public Utilities Code Section 99234; and

WHEREAS, the adopted HCAOG TDA Rules and Regulations, consistent with existing law, has a set-aside for pedestrian and bicycle allocations equivalent to 2% of the money remaining in the fund after allocations to higher purposes, and shall be made available to the county and cities; and

WHEREAS, HCAOG is responsible for reviewing and approving annual transportation claims, and for making allocations from the Local Transportation Fund and State Transit Assistance Funds; and

WHEREAS, for the 2023 cycle a single project was approved with Resolution 23-02, (City of Arcata Bike Share Program with Cal Poly, \$17,400) leaving \$44,600 of 2023 funds unspent, with the remainder to be available for qualifying projects upon request; and

WHEREAS, the City of Blue Lake has requested funding consistent with HCAOG TDA Rules and Regulations and the Regional Transportation Plan, and will submit a TDA claim for pedestrian and bicycle allocations pursuant to all applicable statutes and regulations for the purposes of Article 3, Section 99233.3(a), Pedestrian and Bicycle Allocations; and

NOW, THEREFORE, BE IT RESOLVED that HCAOG authorizes the Executive Director to approve payment, not to exceed five thousand dollars (\$5,000) of the Local Transportation Funds for bicycle and pedestrian purposes as authorized by the California Public Utilities Code Section 99233.3, and by the California Code of Regulations Section 6655.2; and
